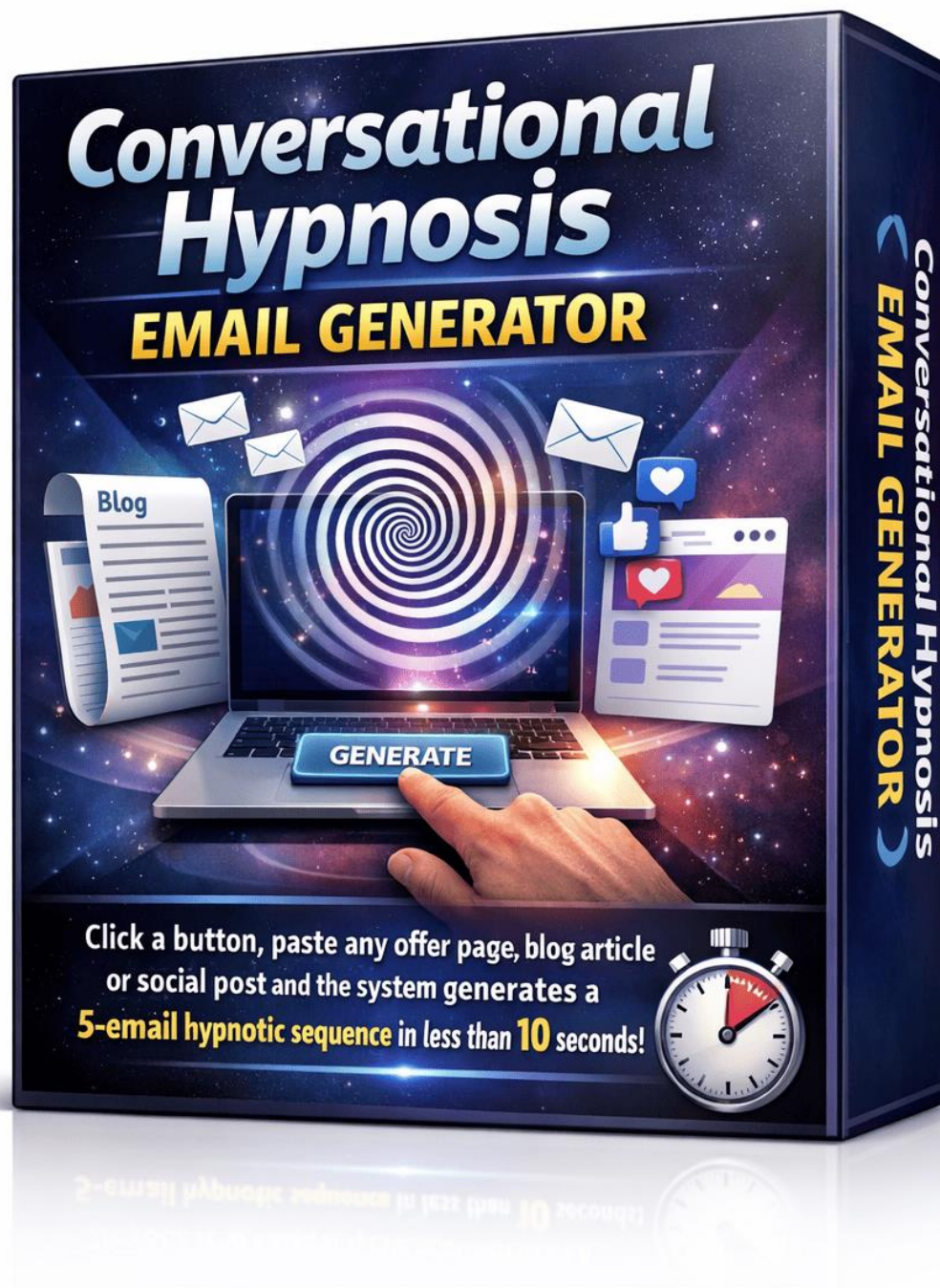




**PLR License**

This license applies to the **Conversational Hypnosis Email Generator** and its included materials, which may include **email-writing content, reports, images, Word documents, PDFs, notepad/text files, PNG files, and GPT documents**.

### **[YES] You CAN**

- You can **edit, rewrite, and customize** the content included in this product.
- You can **rebrand the materials with your own business name, brand name, or logo**.
- You can use the content to create your own version of the product for your audience.
- You can use the included material inside your own **paid digital products, mini offers, courses, or training products**.
- You can use parts of the content inside **email sequences, newsletters, and promotional email content**.
- You can use parts of the content in **blog posts, social posts, lead magnets, and content marketing**, as long as the use follows the restrictions below.
- You can **bundle the finished product** with other paid products.
- You can use the finished product as a **paid bonus, upsell, downsell, or order bump**.

## **[NO] You CANNOT**

- You cannot **pass PLR rights** to your buyers.

- You cannot sell or share the product with **private label rights attached**.

## **Examples of not allowed use**
